
1 IT HEREBY IS ORDERED that the following rights to payment of Judgment Debtor,
2 ORENTAL JAMES SIMPSON (a.k.a. O.J. Simpson) be, and hereby are, assigned to the
3 Judgment Creditor FREDERIC GOLDMAN, an individual, and as personal representative of the
4 Estate of Ronald Lyle Goldman, Deceased, until such time as the judgment herein is fully
5 satisfied or this order is amended:

7 Any and all monies, accounts receivable, royalty rights and all other rights to payment in
8 favor of ORENTAL JAMES SIMPSON or held in the name of any surrogate or nominee for
9 the benefit of SIMPSON, his children or any third party, etc., including but not limited to
10 Lorraine Brooke Associates, Inc., arising from the HarperCollins Publishers Agreement dated
11 May 8, 2006. This order shall include, but is not limited to, any copyright acquired or option
12 exercised under said Agreement. HarperCollins Publishers, along with any assigns or
13 successors, are ordered to pay the assigned property to Judgment Creditor FREDERIC
14 GOLDMAN, an individual, and as personal representative of the Estate of Ronald Lyle
15 Goldman, Deceased, to be applied to the judgment herein until such judgment is fully satisfied or
16 this order is amended.

18 IT IS FURTHER ORDERED that SIMPSON is hereby restrained from assigning,
19 mortgaging, encumbering, advancing, cashing, negotiating, selling, alienating or otherwise
20 disposing of the above rights to payment, accounts, accounts receivable, and royalty rights
21 pursuant to California Code of Civil Procedure Section 708.520(a).

24 COMPLY WITH THIS ORDER MAY SUBJECT THE JUDGMENT DEBTOR TO BEING
