IT HEREBY IS ORDERED that the following rights to payment of Judgment Debtor, ORENTHAL JAMES SIMPSON (a.k.a. O.J. Simpson) be, and hereby are, assigned to the Judgment Creditor FREDRIC GOLDMAN, an individual, and as personal representative of the


1 Estate of Ronald Lyle Goldman, Deceased, until such time as the judgment herein is fully  
2 satisfied or this order is amended:

4 Any and all monies, accounts receivable, royalty rights and all other rights to payment in  
5 favor of ORENTHAL JAMES SIMPSON or held in the name of any surrogate or nominee for  
6 the benefit of SIMPSON, his children or any third party, etc., arising from Mr. Simpson's  
7 participation or appearance, either individually or as part of any NFL team, in any films, movies,  
8 videos, reproductions, compilations, collections, or special orders produced, distributed, made,  
9 photographed, made available by any means, sold or otherwise disseminated by N.F.L. Films,  
10 Inc., a Delaware corporation, whose address is N.F.L. Films, One NFL Plaza, Mt. Laurel, NJ  
11 08054. All third parties obligors or payors involved with the NFL movies, films, videos, or other  
12 commercial media are ordered to pay the assigned property to Judgment Creditor FREDRIC  
13 GOLDMAN, an individual, and as personal representative of the Estate of Ronald Lyle  
14 Goldman, Deceased, to be applied to the judgment herein until such judgment is fully satisfied or  
15 this order is amended.

17 IT IS FURTHER ORDERED that SIMPSON and any of his agents or representatives are  
18 hereby restrained from assigning, mortgaging, encumbering, advancing, cashing, negotiating,  
19 selling, alienating or otherwise disposing of the above rights to payment, accounts, accounts  
20 receivable, and royalty rights pursuant to California Code of Civil Procedure Section 708.520(a).

23 COMPLY WITH THIS ORDER MAY SUBJECT THE JUDGMENT DEBTOR TO BEING
