2 and Isabel Shisler. Third Party Claimants, appearing In Pro Per, and the court having previously
3 set this matter for hearing to adjudicate the Third Party Claims of Dee Shisler and Isabel Shisler,
4 and the court having noted that no opposition or reply having been filed by Dee Shisler or Isabel
5 Shisler, and the court having considered and denied a request for a continuance, and the court
6 having considered the Third Party Claims of Dee Shisler and Isabel Shisler, and under the auspices
7 of C.C.P. § 720.390, which authorizes the court to provide for the disposition of the property, and
8 such other relief as may be appropriate, and for good cause appearing,

9 IT IS HEREBY ORDERED that the Third Party Claims in Case No. 109CV159153 dated
10 10/4/2010 and Case No. 109CV 159158 dated 9/30/2010, are hereby denied in their entirety, and
11 that Dee Shisler and Isabel Shisler shall be declared to have no right, title or interest, or any part of
12 the same, in and to those certain motor vehicles as described below:

13 1995 Dodge Viper - VIN #1B3BR65E6SV201107;

14 1997 Lamborghini Diablo - VIN #ZA9RU37B3VLA12789;

15 2002 Ducati - VIN #2DM1SB5V82B015811 or ZDM1SB5V82B015811.

17 IT IS FURTHER ORDERED that any putative interest, if at all, of Dee Shisler and Isabel
18 Shisler, shall be set aside, avoided, and declared null and void therein.

19 IT IS FURTHER ORDERED that BRYAN SHISLER shall be deemed the owner, by both
20 title and beneficial interest, in and to the Motor Vehicles as set forth therein, and that the judgment
21 creditors have in fact levied and executed upon the right, title and interest of BRYAN SHISLER in
22 and to the Motor Vehicles therein.

23 IT IS FURTHER ORDERED that the Santa Clara County Sheriff is authorized to sell the
24 Motor Vehicles, and each of the same, free and clear of any claim of interest, whether by way of
25 the Third Party Claims, or otherwise, of Dee Shisler and Isabel Shisler, and each of the same, and
26 that Dee Shisler and Isabel Shisler shall have no entitlement to any monies, funds, profits or
27 proceeds from the sale thereof.

1 IT IS FURTHER ORDERED that the Santa Clara County Sheriff, or other subordinate
2 judicial officer, shall be authorized to execute any and all documents, instruments, registrations,
3 certificates, or other writings which are required by the Department of Motor Vehicles of the State
4 of California to facilitate the sale of the motor vehicles and the conveyance of the right, title and
5 interest of BRYAN SHISLER in and to the Motor Vehicles, to and on behalf and for the benefit of
6 any buyer of the Motor Vehicles at the Sheriff's Sale thereunder.

7 IT IS FURTHER ORDERED that BRYAN SHISLER, Dee Shisler and Isabel Shisler, are
8 hereby restrained, stayed, prohibited and enjoined, from taking any action, which would include
9 the lien, mortgage, hypothecation, transfer, sale, or any other acts to alter, change, or amend the
10 title, whether legal, beneficial, or otherwise, in and to the Motor Vehicles, or any one of the same.

11 IT IS FURTHER ORDERED that any and all restraining orders as previously issued by this
12 court shall remain in full force and effect, and that BRYAN SHISLER, Dee Shisler and Isabel
13 Shisler, shall be bound thereto.

14 IT IS FURTHER ORDERED that this court shall keep and retain continuing jurisdiction
15 for the purposes of entering any and all other supplemental orders, judgments or decrees which
16 may facilitate the orderly sale by the Santa Clara County Sheriff in and to the Motor Vehicles
17 herein.

18 IT IS FURTHER ORDERED that the Santa Clara County Sheriff shall be authorized to sell
19 the Motor Vehicles, and each of the same, for the benefit of payment of the judgment herein, either
20 in part or in whole, even though the registered owner for the Lamborghini is putatively in the name
21 of the Third Party Claimants thereunder.

22 IT IS FURTHER ORDERED that this order and relief therein shall be deemed a judgment
23 of this court, denying the Third Party Claims herein and entered the relief therein.


