4 IT IS HEREBY ORDERED that the MOTION FOR ASSIGNMENT OF RIGHTS AND
5 RESTRAINING ORDER AS TO GOLDFEIN & JOSEPH ("Goldfein") is hereby granted.

6 IT IS FURTHER ORDERED that all rights, payments, monies, funds, cash, proceeds, or
7 funds monies cash or proceeds ^{of Asbestos Corporation Limited} held in the possession of GOLDFEIN & JOSEPH, the law firm ^{DUK}
8 located at 1880 JFK Boulevard, 20th Floor, Philadelphia, PA 19103, ("Goldfein") pursuant to
9 C.C.P. § 708.510(a), are hereby assigned to Plaintiffs JOSEPH GARZA and MARY GARZA, care
10 of its attorney, David J. Cook, Cook Collection Attorneys, PLC, 165 Fell Street, San Francisco,
11 CA 94102, for purposes of payment of the Judgment in the amount of \$11,239,005.53, in which
12 the current balance as of July 30, 2010 is not \$15,700,736.77, plus additional interest and costs as
13 may be allowed.

14 IT IS FURTHER ORDERED that Defendant ACL, or any of its officers, directors,
15 shareholders, or other persons on its behalf, is hereby restrained, stayed, prohibited and enjoined
16 from the transfer, alienation, disposition, hiding, secreting, or otherwise disposing of any and all
17 rights, if any, due, from, and held by Goldfein.

18 IT IS FURTHER ORDERED that any previous opposition filed by ACL is stricken
19 pursuant to the order of this court disentitling [the court having granted relief on January 20, 2011]
20 ACL from responding to any motions or other process seeking to enforce this judgment against
21 assets of ACL which should have been revealed by way of responding to the post-judgment
22 interrogatories pursuant to the order of November 23, 2010.
